## Waiver and Release of Liability

In consideration of being permitted to participate in the Professional Geoscientists Ontario (PGO) Mentoring Program, I acknowledge and agree to the following terms:

- 1. **Voluntary Participation:** I understand that my participation in the PGO Mentoring Program is entirely voluntary and not a requirement of registration. I acknowledge that any participation is at my own discretion and risk.
- 2. **No Guarantees or Professional Liability:** I acknowledge that PGO provides this Mentoring Program as a professional development resource. PGO does not guarantee specific outcomes, career advancement, or professional success as a result of participation. I understand that mentors are not acting as agents or employees of PGO and are not licensed by PGO as advisors, employers, employees, or legal representatives.
- 3. **Release of Liability:** I hereby release, waive, and forever discharge PGO, its directors, officers, employees, volunteers, agents, and representatives (collectively, "PGO Releasees") from any and all claims, demands, actions, causes of action, liabilities, losses, damages, costs, and expenses (including, but not limited to, reasonable legal fees and expenses) of any kind whatsoever, which I may have or suffer or which may hereafter arise against PGO Releasees or any of them, arising out of or in any way relating to my participation in the PGO Mentoring Program.
- 4. **Scope of Release:** This release includes, but is not limited to, any liability arising from or related to:
  - The use of the virtual Platform/App provided for the Mentoring Program.
